Beet Greens Pesto

Like most dark, leafy greens, beet greens are loaded with iron and vitamins A and C, and are a great source of calcium, magnesium, folate, vitamin K, potassium and more! Rather than toss those tops, why not give this tasty pesto a try!

Ingredients:

- 4 c. beet greens
- 4 cloves garlic
- 1/4 tsp. freshly ground black pepper
- 1/2 tsp. salt
- 1/4 c. extra-virgin olive oil
- 1/2 c. pine nuts
- 3 tbsp. grated Parmesan

Place all the ingredients in a blender or food processor. Process on high until all ingredients are pulverized into paste. Store in the fridge in an airtight container for up to one week.

What's Happening IN AG?

Good Agricultural Practices Audits: What you need to know.

Food safety is a growing concern for many wholesalers and retail establishments. Good Agricultural Practices (GAP) audits verify that produce is grown, harvested, packed, and stored in ways that minimize microbial food safety hazards. They offer significant benefits, including protecting the health of your customers, reducing economic risk for farm businesses, and increasing access to market opportu-

nities.

Farmers interested in

selling fresh fruits or vegetables to wholesale markets or distributors may be asked for a "third-party food safety audit." A GAP audit verifies to buyers that you grow, harvest, wash and pack your fresh produce in accordance with recommended safety guidelines.

GAP Audits cover growing, machinery, packing, and harvesting. In order to pass the audit, a food safety plan is required that includes farm history and land use, worker health and hygiene, worker training, water sources/quality, manures and soil amendments, toilet and handwashing facilities, harvesting, packing, storage and transportation, and product traceability.

There is a fee associated with a GAP audit, which is paid by the

grower; however, **Pasa** SUSTAINABLE AGRICULTURE there is a cost-share program that can

reimburse you for up to 75 percent of the cost of the audit once you have the audit certificate.

Prior to the audit, you can review the USDA GAP/GHP audit checklist, which is the same one the auditor will use for your audit. Most audits are completed in 4-5 hours and are required annually. To learn more about GAP Audits, or to participate in a "mock audit" visit PASAfarming.org today.



Ag Lending Remains Strong **Despite Small Decrease in 2020**

Despite the global economic slowdown in 2020 due to COVID-19, total agricultural lending by U.S. farm banks remained strong at \$98.6 billion, decreasing by only 1.8% from the year before according to the American Bankers Association's annual Farm Bank Performance Report. The U.S. banking industry is a critical provider of credit to the agricultural sector. Banks had more than \$174 billion in farm loans outstanding in 2020, accounting for nearly 50% of the total farm credit outstanding in the U.S.

FCCB continues to rank in the top 100 Ag Lenders in our country. In fact, according to first quarter 2021 data, FCCB is currently the 58th top Farm Lender in the U.S.! The Cattle Market Transparency Act aims to improve price discovery by creating new reporting requirements and providing producers with additional information going into negotiations by mandating the creation and maintenance of a library of marketing contracts offered by packers to producers. USDA already maintains a swine contract library, which has a catalog of the types of contracts offered by packers to swine producers for the purchase of swine (including swine that are purchased for future delivery). This new legislation would provide cattle producers valuable information on certain contract provisions already
