

# <u>Veterans Checking Ticket Giveaway Sweepstakes Official Rules</u>

#### 1. SPONSOR

This promotion ("Sweepstakes") is sponsored by FCCB (First Citizens Community Bank), 15 S. Main Street, Mansfield, PA 16933 ("Sponsor"). Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Jason Aldean, any concert venue, or any ticketing platform.

### 2. ELIGIBILITY

Open only to legal residents of Pennsylvania, Delaware, and New York, 18 years of age or older at the time of entry. Employees, officers, and directors of Sponsor, its affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members (spouse, parents, siblings, and children) or persons living in the same household of any of the above are not eligible. Board members of Sponsor and their immediate family members are also ineligible. Void where prohibited by law.

### 3. NO PURCHASE OR ACCOUNT REQUIRED TO ENTER OR WIN

No purchase, payment, or bank relationship is required to enter or win. A purchase, account opening, or any other banking relationship will not increase your chances of winning.

### 4. PROMOTION PERIOD

- In Person Entry: Customers may also enter by speaking with a banker at any of our local community offices. No account opening, deposit, or purchase is required to participate.

All entries, regardless of method, have an equal chance of winning. Limit one (1) entry per person during the Promotion Period.

# 6. PRIZES

Two (2) prizes will be awarded in total:

- Prize #1: Two (2) tickets to see Jason Aldean in concert on January 29, 2026, in State College, PA (ARV \$500).
- Prize #2: Two (2) tickets to see Jason Aldean in concert on January 30, 2026, in Allentown, PA (ARV \$500).

Total approximate retail value: \$1,000. Prizes are non-transferable and no cash or substitution will be permitted except at Sponsor's sole discretion. Winners are responsible for all applicable taxes and expenses not listed herein.

### 7. WINNER SELECTION AND ODDS

Winners will be selected in a random drawing conducted by Sponsor on or about December 16, 2025, from all eligible entries received. Odds of winning depend on the number of eligible entries received. Potential winners will be notified via phone or email within five (5) business days following the drawing. If a potential winner cannot be reached within seven (7) days, the prize may be forfeited and an alternate winner selected.

#### 8. GENERAL CONDITIONS

By entering, participants agree that FCCB may contact you with information about products and services, including the Veterans Checking Account. The participant may opt out of receiving such communications at anytime. Participants agree to abide by these Official Rules and the decisions of the Sponsor, which are final and binding. Sponsor reserves the right to cancel, suspend, or modify the Sweepstakes if fraud, technical failures, or other factors impair its integrity. Sponsor reserves the right to disqualify any individual found tampering with the entry process or violating these Rules.

Except where prohibited, participation constitutes permission for Sponsor to use winner's name, city/state, likeness, and prize information for promotional purposes without additional compensation.

### 10. TAXES
