In late 2014, the FFIEC (Federal Financial Institution Examination Council) released their report on the 2013 lending activity for banks. Their results — First Citizens is **the number one** lender to small businesses and agriculture in Tioga, Bradford and Potter counties.



FCCB Scholarships Deadline March 15th

Each year, First Citizens awards two \$1.000 scholarships to the Mansfield University Foundation who administers the scholarship selection and awards. One scholarship is awarded to an MU student who resides within the First Citizens market. The second scholarship is awarded to a First Citizens employee, local board member, or a dependent of an employee or local board member. Both scholarships require academic excellence and community service, and are available to sophomore, junior and senior college students. To be eligible, students must have a cumulative GPA of at least 3.0 and have 20 hours of community or school service.

The \$1,000 First Citizens Agricultural Scholarship will be awarded to a high school senior, who after graduation will continue his or her education in an agriculture-related field. The scholarship will be paid out to the recipient for their second year in college or trade school upon receipt of the student's prior year transcript. Applicants must have a cumulative GPA of at least 3.0, and reside in the First Citizens market.

Preference for all scholarships will be given to students who are customers or who have family members as customers.

The deadline for submitting applications for the First Citizens Community Bank MU Scholarships and the Ag Scholarship is March 15, 2015. Applications for both scholarships can be found at www.firstcitizensbank.com or at any community office.
